### 2- Preservation Award:

- To a person or a group of people, for an outstanding preservation or restoration activity in the Award year.

### 3- Article Award ( 2 prizes):

- For an article published in *CANADIAN RAIL* or other Division newsletter.
- For an article published in any other periodical or magazine.

### 4- Book Award:

- For a book published in the Award year (2024) or the previous year (2023).

### 5- Multi-Media Award:

- For a Video / Film / DVD / Website on railway related subject.

Nominations will be accepted from members and other persons interested in Canada's railway history. Submissions should bear the name of the nominee, his coordinates (if possible) and the reasons for that person's nomination. The nominator's name and mailing address must be included. Persons or entities other than the nominee should make nominations. A copy of the nominated work should be submitted with the nomination whenever possible. The *Association* guarantees its return to the owner.
